BRIEFING ON BUY IN ANNUITY CONTRACTS

A buy-in can be considered a liability-driven investment (LDI) solution that hedges not only the investment risk but also the longevity risk Like other LDI solutions, it does not eliminate ongoing administrative costs or Pension Benefit Guaranty Corporation (PBGC) premiums In the United States a buy-in, unlike a buyout, includes an
